

OFFICIAL COLORING CONTEST RULES.

1. **No purchase is necessary.**
2. By submitting any entry you agree to be bound by the Official Rules.
3. Entries may be submitted between December 13, 2014 and ends on January 31, 2015.
4. The winner will be notified by DCCU.
5. Limit one (1) prize per household. If any prize is unclaimed, an alternate winner will be chosen.
6. Voting will be held on Dane County Credit Union's Facebook page at <https://www.facebook.com/DaneCountyCU>. A minimum of 25 entries is necessary before voting begins. We reserve the right to extend the deadline in an effort to meet that minimum.
7. DCCU will award three (3) Visa gift cards to the three contest entries with the most LIKES on Facebook.
8. Entries will be entered in the contest upon receipt of an official DCCU entry form or written entry on a 3 x 5 piece of paper setting forth the entrant's name, address, age, and, telephone number to Dane County Credit Union Coloring Contest, PO Box 7994, Madison, WI 53707-7994. Entries must be postmarked no later than January 31, 2015. The Credit Union is not responsible for lost, late, misdelivered, incomplete or postage-due entries. One entry per person during the entire promotion.
9. To claim a prize, the winner must sign and return a release and an affidavit of eligibility and publicity release to the Credit Union at 2160 Rimrock Road, Madison, WI 53713, within 14 days of notification, or prize will, in the Credit Union's discretion, be forfeited. Prize will be awarded only if entrants comply with these Official Rules. No cash or other consideration will be paid and winners are responsible for any applicable taxes or other expenses related to any prize awarded. Odds of winning rely entirely on the number of entrants.
10. Void where prohibited by law. All federal, state and local laws and regulations apply.
11. By accepting a prize, a winner consents to the use of his/her name and photograph or likeness for advertising and promotional services without additional compensation.

The winner releases any liability, claims, actions, demands, and damages relating to any publication, distortion, blurring, alteration, optical illusion, or use in composite form or otherwise that may occur or be produced intentionally or otherwise, even should this subject the undersigned to ridicule, scandal, reproach, scorn or indignity.

Winners will be selected from the top 3 eligible LIKE getting entries from among the eligible entrants received and the selection will be final and the prize will be awarded pursuant to these official rules.
